### Office Order

She should report to the Bangladesh High Commission in the United States of America for registration of her name within 7 (seven) days after her arrival in the USA.

She has submitted requisite bond and undertaking according to Government's order to serve the relevant department of this University for a period of 3 (three) years.

On return she is supposed to submit a comprehensive report of her studies to the Ministry of Education and the Vice-Chancellor of this University.
