She should report to the Bangladesh High Commission in USA for registration of her name within 7 (seven) days after her arrival in USA.

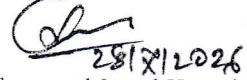
She has submitted requisite bond and undertaking according to Government's order to serve the relevant department of this University for a period of 3 (Three) years.

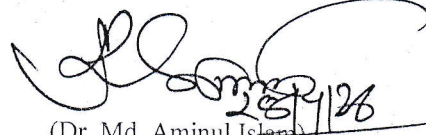
