He should report to the Bangladesh High Commission in USA for registration of his name within 7 (seven) days after his arrival in USA.

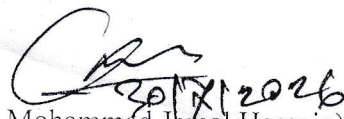
He has submitted requisite bond and undertaking according to Government's order to serve the relevant department of this University for a period of 5 (five) years.
